# Working, learning, playing... living places

## Presentation and scope


This Prize aims to recognise excellence in architecture. It distinguishes those works which strengthen the ability of adaptability of spaces to reach comfort and well-being to its residents. Architecture which turns into quality places for people's every day lives: for working, learning, playing, ... Architecture to be lived in.

The contest is open to all works completed and put into use between January 1 2016 and December 31 2017 and built on European and Mexican territories.

Living Places – Simon Architecture Prize is an initiative on the part of Simon developed by the Fundació Mies van der Rohe.

# Presentation

A prize that **understands excellence as the provision of an added value**: when interest goes beyond aesthetics and works stand out not so much by virtue of their programme but rather of a quality that makes them unique, in which skill and inventiveness combine as motors to devise precise, specific action strategies.

A prize that **focuses on the realm of the inhabitant**. The inhabitant understood as the user, the citizen, the passer-by, the general public... someone who is one and many at the same time, who constitutes neither the prototype nor the model of any particular lifestyle, who is defined by the relationship generated between activity and the type of space: who plays, works, sleeps, eats, walks, listens, learns, speaks... in the kitchen, in the square, in the office, in the market, in the opera, in the block, in the bedroom, in the park... **who fills spaces with life and endows them with meaning**.

A prize as **a framework for reflection** on the nature of this contribution and the relationship it establishes with this inhabitant. **What does the project contribute?**: more square metres? The creation of public space? Improvement of the surroundings with existing resources? ... And **what effect does this contribution have on the user?**: a feeling of warmth? A feeling of belonging to the place? Comfort? Flexibility and greater freedom of movement?...

## Scope

The contest is open to all works completed and put into use **between January 1 2016 and December 31 2017** and built on European and Mexican territories. Works that stand out by virtue of their special qualities and worthy of consideration and discussion on the part of the jury within the proposed debate parameters. w

An indispensable condition is that such works are in use, that is, that they have been handed over to the inhabitant, to society, to the city... placed at the service of activity in interaction with multiple factors, with that which endows them with their *raison d'être*.

The contest calls for entries from all those architects, urban planners and/or landscapists<sup>1</sup> responsible for the proposed works, resident in any country and regardless of nationality or age. Works may be presented by individuals or by multi-disciplinary teams of which at least one member is an Architect.

# Lived-in places and places for living

## **The Prize structure: categories**

Collective Places and Personal Places constitute the two categories around which the Prize is structured and reflect our interest in architecture planned and explained from the user's perspective. An interest that focuses on experiences that put spaces to the test rather than on degree 0 of architecture frozen in the instants prior to being handed over to society and the city.

# Categories

The definition of the categories around which this Award is structured has to do with this focus on the individual and the links he or she establishes with space, on how individuals appropriate space to themselves, thereby converting it into place.

Making a parallel with the field in which Simon, the proponent of this Award, specialises, the two categories might be defined initially on the basis of the following relationship: in collective places a consensus must be reached among individuals before turning a switch on or off, whereas in personal places it is the individual who decides whether to do so or not.

We might take the room, understood as a minimal unit, as the departure point from which to describe the **Personal Places** category, the place with which we associate our ideal of comfort and privacy. The room is therefore normally associated with the domestic sphere, with the home, which might also be regarded as a personal place. However, to what extent does this depend on the number of people who share the home and the relationship between them? A home may be occupied by a couple with their children and a grandmother, or by five students, or by a couple and their dog, or by three sisters... In these cases, would the home be regarded as a personal or as a collective place? Likewise, a room may also be linked to a wide variety of uses and places: in an office building, as the director's office; in a hospital, as the consultation room; in a geriatric hospital, as a temporary place of residence ... Might the work environment (table, chair, computer...) in an office be regarded as a personal place?

The **Collective Places** category refers to spaces in which community and/or public life unfolds: markets, schools, streets and squares, concert halls, housing blocks, parks... Might collective places be defined as all those places that are not personal? Might a piece of landscaping be regarded as a collective place? Might an airport be regarded as a collective place? Do non-places exist and consequently spaces that would not be eligible for this Prize?

The Prize is structured around two categories that are characterised as being inclusive, not categorical. There is no strict demarcation line between the two: they are conceived as a **guideline for reflection on the personal and collective spheres** in relation to the proposed entry.

The entries must be sensitive to the issues raised above and assigned to one of the two categories. The choice of category will be linked to the most prominent characteristics of the project and must be justified in a written description and audio-visual document (both of which are described in the **Documents to be submitted** section of the next chapter **Make us....get to know your project**).

If the same entry has an equal number of qualities relevant to both categories, it may be assigned to both (in which case it is compulsory to make two separate inscriptions, one per category, and present a different text and video for each inscription).



# Make us... get to know your project

## **Prize methodology: documents to be submitted and procedure**

The focus on the inhabitant is also reflected in the Prize methodology. The video, considered to be an instrument to bring architecture closer to the public in general and to convey the atmosphere of the place, is the main document to be submitted. The participation process includes users, inhabitants and citizens and allows them to propose those works they regard as worthy of consideration on the part of the jury.

# Documents to be submitted

The moving image is a technique increasingly used to explain an architectural project to a client and to make the built result understandable to everyone. Hitherto, the video in architecture has served as a documentary tool, in most cases produced by professional film-makers. For this Prize we propose that Architects, together with users, convey their ideas, challenges and sensations through the moving image.

Besides the video, descriptive texts, drawings, photographs and so on must also be submitted in accordance with the following list:

1. A **video**<sup>2</sup> lasting 3 minutes maximum and conveying the atmosphere and life of the place.
2. A **descriptive report on the project** in English of 500 words maximum. The report must be divided into two parts (maximum 250 words per part), the first containing an overall description of the project (design concept, location and previously existing conditions, use of materials, etc.) and the second constituting a specific description of the project in terms of the category to which it has been assigned (Personal Places or Collective Places, described above in the Lived-in places and places for living. The Prize structure: categories section).
3. **Graphic documents:**
  - A DIN A2 panel featuring the most significant project drawings and photographs (composed in accordance with the pattern and example you may download from the award website).
  - A selection of 6 representative and explicative plans and drawings so that the jury may perfectly understand the project.
  - A selection of 6 photographs of the work (72 dpi/ max 1Mb each).

## Procedure

### Nominators

The participation process in this Award is based on two concepts: the figure of the nominator and the work proposed and those responsible for it.

The nominator proposes the entry. The Architects responsible for the work, their collaborators<sup>3</sup> and the clients or users<sup>4</sup> who wish to do so may assume this role. The nominator carries out the registration and provides the information on the proposed work (see the **Registration and submission of materials** section below).

This contest, therefore, besides contemplating the option that Architects may nominate their own works, is also open, for example, to clients who are very satisfied with the result of their assignment, or to occupants of a space in which they feel very much at home, or to students who go to library which they find very inspiring, or to a supplier who feels he has contributed to a specific project... In short, anyone who wishes to express their appreciation may do so by entering the work in question for the Prize<sup>5</sup>.

### Registration and submission of materials

The participation process involves two steps: registration and submission of material, both exclusively online through the [simonprize.org](http://simonprize.org) website.

The first step is registration, which consists of completing the form in the **Participation** section. Once you have done this you will receive an e-mail with a username, a password and a link through which you may submit the material described in **Documents to be submitted** section.

### Prize

The jury will select 5 finalist works per category, from which they will select 1 winner for each. The Architects responsible for the winning entries will receive a cash prize of **10,000€<sup>6</sup>** per category.

The organisers of the Prize encourage the winners to tell us to what use they will put the prize money.

### Calendar

Presentation of the Prize and open call for entries: 3rd of July 2018

Registration: until 10th of September 2018

Document submission: until 8th of October 2018

Publication of the finalist entries: beginning of November 2018

Jury's verdict: October 2018

Granting ceremony: end of November 2018 at the Espacio Simon 100 in Barcelona

### Jury

The jury will consist of 5 members and will be announced in July 2018 via the website ([simonprize.org](http://simonprize.org)) and social networks (Facebook: [simonprize](https://www.facebook.com/simonprize)).

The Prize may not be declared void and the jury's verdict will be final.

Fundació Mies van der Rohe (hereinafter called Fundació Mies): for the NOMINATORS' participation in the Living Places – Simon Architecture Prize (hereinafter collectively called Simon Prize):

1.- License: NOMINATORS grant Fundació Mies a non exclusive license to reproduce, distribute, communicate and make available to the public and transform all the elements contained in AUTHOR SUBMISSION DOCUMENTS in any digital or analogue format or way of exploitation related to the promotion or communication of the Simon Prize. Transformation right shall be limited to any modifications on AUTHOR SUBMISSION DOCUMENTS for the purposes of editing in specific means of publication.

Credit: In any reproduction of AUTHOR SUBMISSION DOCUMENTS Fundació Mies shall do its best efforts to mention the name of the authors and the NOMINATORS unless this is not a usual practice according to a specific mean of publication.

2. - NOMINATORS DECLARE and GUARANTEE to be the sole authors or copyright owners of all the elements included in AUTHOR SUBMISSION DOCUMENTS, elements which have been developed originally by their authors (specifically drawings, photographic or audiovisual content produced by third parties) and therefore any authorized use of AUTHOR SUBMISSION DOCUMENTS will not infringe upon or violate any Intellectual Property Rights of any third party anywhere.

NOMINATORS shall indemnify and hold Fundació Mies harmless against all loss, cost, liability or expense (including legal fees on a full indemnity basis) and all claims of third parties based on possible infringement of Intellectual Property Rights of any third party in relation to AUTHOR SUBMISSION DOCUMENTS.

3.- Image and bio: NOMINATORS authorize Fundació Mies to take (by photography or any other audiovisual means) the NOMINATORS' personal image during the NOMINATORS' participation in any event related to the Simon Prize, and to reproduce and publish it (as well as other of authors' images and biographical data provided by NOMINATORS) in any way of communication or promotion of the Simon Prize.

4.- Extension: The license on AUTHOR SUBMISSION DOCUMENTS and the right to use the NOMINATORS' image shall be non exclusive and without any temporal or territorial limitation. The Fundació Mies shall have the right to assign the rights licensed herein to any third party, and specifically to Simon S.A.

## Privacy policy

The participants accept and give their express consent to the personal data provided for registration for the competition being processed by the Fundació Mies van der Rohe with registered address at C/ Provença 318, 08037, Barcelona and by Simon, SA with registered address at Diputació 390, 08013, Barcelona for the purpose of developing all the activities necessary to administer the competition. The delivery of the personal data for registration for the competition is compulsory in order to be able to formalize the registration and adequately administer the competition.

Participation in the competition shall entail the publication of the identifying data of the participants and winners of the award on the website/s of the Fundació Mies van der Rohe and of Simon, SA, and on the social networks of both entities and in the media.

The legal basis for the aforementioned processing is the consent of the participants which is formalized on accepting the privacy policy during the registration process.

The participants guarantee that the Personal Data provided to the Fundació Mies van der Rohe and Simon, SA for participation in the competition are accurate and accept responsibility for communicating any modification to the same.

Provided that the participants expressly consent to this on completing the registration form for the Competition, the Fundació Mies van der Rohe and Simon, SA may use these data to maintain contact with the participants and inform them of their activities and services and/or products, including sending promotional communications by electronic means. The data of the participants shall be conserved indefinitely, with the aim of maintaining the historical details of the works presented to the competition with the identification of their authors. In relation to the processing of the data with the aim of maintaining contact between the parties, the data shall be conserved until you indicate otherwise.

At any time, the participants may exercise their rights of access, rectification, cancellation, opposition, limitation of the processing and portability in relation to their personal data, by writing to:

In any case, Fundació Mies van der Rohe and Simon, SA commits to communicate by this mean the modification of the guidelines, or the voiding, so that all participants have access to that information.

# FAQ

## Questions most often asked

### **What kind of works may be submitted?**

All works completed and occupied between January 1 2016 and December 31 2017 and built on European and Mexican territory.

### **Who may submit works?**

The architects, urban planners and/or landscape architects (hereinafter collectively called Architects) responsible for the works, regardless of nationality and country of residence. They may present their works either individually or as a team.

### **Who may propose works?**

Option A: the Architects responsible for the works.

Option B: collaborators.

Option C: residents (any citizen).

Option D: clients.

### **Is there any submission fee?**

No, inscription for and participation in the Simon Architecture Prize are entirely free of charge.

### **How many works may be submitted?**

There is no limit.

### **How many works by the same Architect may be submitted?**

There is no limit.

### **How may the required documents be submitted?**

The documentation relating to the works must be submitted through the website ([simonprize.org](http://simonprize.org)). You must sign up on the website to send the requested documents.

### **Who may submit the requested documents?**

Option A: the Architects responsible for the proposed works.

Option B: collaborators to the proposed works endorsed by the Architects responsible.

Option C: residents of the proposed works endorsed by the Architects responsible.

Option D: clients of the proposed works endorsed by the Architects responsible.

## **Who decides in which of the two categories the works are submitted?**

Option A: the Architects responsible for the proposed works.

Option B: collaborators to the proposed works endorsed by the Architects responsible.

Option C: residents of the proposed works endorsed by the Architects responsible.

Option D: clients of the proposed works endorsed by the Architects responsible.

## **May the same work be submitted to both categories (Collective places and Personal places)?**

Yes. In this case, two inscriptions must be made separately, one for each category.

Furthermore, a different audio-visual document (video) must be submitted for each of the two categories.

## **Who is granted the 10.000€ cash award for each of the two categories?**

The Architects responsible for the winning works.

## **Should the winning works have been proposed by clients, collaborators or residents, will they receive any kind of acknowledgement?**

Yes. In this case they will be invited to attend the prize-giving ceremony, during which they will be acknowledged for their contribution to the Simon Architecture Prize.

## **May the Simon Architecture Prize be declared void?**

No. It is the obligation of the present edition's Jury to announce five finalist works and select one as the winner in each of the two categories.
